TO THE RESPONDENTS:

A lawsuit has been started against you in the above-entitled Court by Sno-King Watershed Council, petitioner. Petitioner's claim is stated in the written Petition for Review, a copy of which is served upon you with this Summons.

In order to defend against this lawsuit, you must respond to the Petition for Review by stating your defense in writing, and serve a copy upon the undersigned attorney for the petitioner within 20 days if service of this Summons is made upon you within the State of Washington, or within 60 days if service is made upon you outside of the State of Washington, excluding the day of service, or a

1 default judgment may be entered against you without notice. A default judgment is one where the  
2 petitioner is entitled to what it asks for because you have not responded. If you serve a notice of  
3 appearance on the undersigned attorney, you are entitled to notice before a default judgment may be  
4 entered.

5 You may demand that the petitioner file this lawsuit with the Court. If you do so, the demand  
6 must be in writing and must be served upon the petitioner. Within 14 days after you serve the demand,  
7 the petitioner must file this lawsuit with the Court, or the service on you of this Summons will be void.

8 If you wish to seek the advice of an attorney in this matter, you should do so promptly so that  
9 your written response, if any, may be served on time.

10 This Summons is issued pursuant to Rule 4 of the Superior Court Civil Rules of the State of  
11 Washington.
